1.ISETHULO

1.1 Lelibhukwana elimayelana neminingwane yokuthola ulwazi kwa-Transnet lishicilelwwe ngaphansi kwesigaba 14 somthetho ogquqquzela ukuthi abantu bathole ulwazi abaludingayo i-Promotion of Access to Information Act, 2000 (Act No. 2 of 2000) ("i-PAIA") kanti futhi liyakhulumna nangodaba loMthetho ongamele ukuvikelwe kweminingwane yakho phecelezi i-Protection of Personal Information Act, 2013 (Act No. 4 of 2013) ("i-POPIA").

1.2 Umthetho i-PAIA usekela isigaba 32 soMthethosisekelo esigquqquzela ukuthi abantu ababe nelungelo lokuthola imininingwane ekuHulumeni kanye naleyo ekomunye umuntu uma idingeka ngenhloso yokwenza okuthile, kumbe ukuvikela nanoma iliphi ilungelo.

1.3 Inhloso ye-PAIA ukugquqquzela ukuthi yonke into ibe sobala kuHulumeni kanye nasezinkampanini ezizimele ngokuthi kunikezwe abantu ilungelo lokuthola imininingwnae abayidingayo abangaphinde bayisebenzisele ukuvikela amalungelo abo.

1.4 Inhloso yalelibhukwana ukudalula imininingwane ngokumele kwensiwe nemigudu okumele ilandelwe ukuthola imininingwane engaphansi kwenkampani yakwa-Transnet SOC Ltd.

2.UKUTHOLAKALA KWALELIBHUKWANA

2.1 Lelibhukwama litholakala kwi-website yenkampani yakwa-Transnet ku-www.transnet.net noma ngokuthi ufake isicelo nge-email komunye wabasebenzi abanikezela ngolwazi njengoba kubalulwa kwisigaba 4 ngezansi.

2.2 Isigaba 110 somthetho i-POPIA sifaka izichibiyelo kumthetho i-PAIA, nezaqala ukusebenza kusukela mhlaka 1 July 2021. Lelibhukwana lifaka phakathi izichibiyelo kwisigaba 10 no-14 soMthetho esigcizelela ukutholakala kwalo kanye nesigaba 25 siomthetho i-PAIA ofaka phakathi okumele kwensiwe ilowo ofaka isicelo, ukuthi afake isikhala kwengamele ukukhishwa nokuvikelwa kweminingwane phecelezi i-Information Regulator uma ngabe senqatshwa isicelo sokuthola ulwazi kumbe imininingwane ayidingayo.

3.UMSEBENZI WE-TRANSNET NEZINHLAKA ZAYO

I-Transnet inkampani kaHulumeni eyenza umsebenzi wokuthuthwa kwempahla nokuhambisana nalokho. Inkampani yakwa-Transnet inamachweba, imizila kaloliwe, izikhumulo zokubeka impahla, ezobunjiniyela, amapayipi kawoyela negesi kanye nebhizinisi lezakhiwo.

Inkampani yakwa-Transnet yakhiwe ilezinhlakala ezilandelayo:

3.1 I-Transnet National Ports Authority: (TNPA)

Loluhlaka lwakwa-Transnet lunabasebenzi abangu 4, 168 (lapha kubalwa nabasebenzi abayitoho) Umsebenzi walo ukuinisekisa ukuthi wonke amachweba asebenza ngendlela efanele. Iyona iTNPA engamele ukuphathwa kwengqalasizinda kanye nokuphathelene nokusebenza kwamachwema ayishishagalombili akuleli okuyi-Richards Bay, eThekwini, e-Saldanha, eKapa, eGqeberha, East London, Mossel Bay kanye neNgqura.

I-TNPA iseenza ngaphansi kwezimiso zomthetho obhekele amachweba, owaziwa nge-National Ports Act 2005 (Act No. 12 ka 2005). Nakhu okubalulekile okwenziwa i-TNPA ngaphansi kwezimiso zomthetho ongamele amachweba, phecelezi i-NPA:

3.2 I-Transnet Port Terminals:

I-Transport Port Terminals (“TPT”) isingulwe ngonyaka ka 2000 ngesikhathi inkampani yakwa-Transnet engamele amachweba, i-Portnet ihlukanisa kabili kuba ingxene ebhekele ukusebenza kwansukuzonke kanye nengxene engamele umsebenzi wamachweba, i-South African Port Operations (SAPO), ebe isiba i-TPT. I-TPT idlale indima enku lu ekusekeleni uhlelo lukaHulumeni lokukhulisa ukuthuthwa kwempahla ethunyelwa emazweni angaphandle. Iningi lempahla engenayo nephumayo emazansi nezwakazi lase-Africa kusetshenziswa amachweba akuleli ayisikhombisa okuyi-Richards Bay, eThekwini, Saladnha, eKapa, Gqeberha, East London kanye neNgqura. I-TPT ilawula ukuthuthwa kwama-container, ezokumbiwa phansi, ezolimo kanye nempahla enamasondo kubalwa izimoto namaloli lokhu okubizwa nge-Roro sector.

Amakhasimende e-TPT afaka phakathi imboni yemikhumbi, izinkampani ezakha izimoto, ezolimo, izingodo namahlathi, abezimayini kanye nalabo abathumela ezokumbiwa phansi emazweni angaphandle.

I-TPT inabasebenzi abantu 9, 371 kubalwa nalabo abayitoho.

3.3 I-Transnet Freight Rail:

I-Transnet Freight Rail (“TFR”) inkampani esezingeni lomhlaba egxile ekuthuthweni kwempahla ngemizila kaloliwe . I-TFR enabasebenzi abantu 26, 800 ezweni lonke. Lenkampani yenza umsebenzi wokugcina imizila kaloliwe iseenza ngendlela efanele. Imizila kaloliwe yalenkampani nengqalasizinda isiyonke ingu 80% uma kuhlanganisa yonke i-Africa.

I-TFR iyaziqhenya kakhulu ngobuchwepeshe bayo obusezingeni eliphezulu e-Africa nasemazweni angaphandle. I-TFR izibeke ezingeni lokuba inkampani eyenza inzuko nokusiza umnotho wakuleli ubesezingeni lokuncintisana nowakwamanyi amazweni.

I-TFR iphinde ibambe iqhaza kwingosi yozokungcebeleka nge-Blue Train. I-Blue Train inomzila oyibanga elingu 1600-kilometre phakathi kwePitoli kanye neKapa.

3.4 I-Transnet Pipelines (“TPL”):

I-Transnet Pipelines (“TPL”) ingamele ukuthuthwa kwegesi kanye nowoyela, iphinde igcine udizili nophethiloli esizindeni sayo i-Tarlon, eGauteng. Lelihizinisi lakwa-Transnet ilawula uwoyela obalelwa ku 17 billion litres kanye negesi elingaphezulu 500 million cubic metres. Imikhiqizo ewuketshezi esatshalalisa ilenkampani, kubalwa uwoyela ongahluziwe, udizili, uphethiloli kanye nowoyela wezindiza.

I-TPL inamapayipi egesi nowoyela ubude bawo obubalelwa ku 3, 800 km anqamula phakathi kwe-KwaZulu-Natal, Freystata, Gauteng, North West naseMpumalanga. Lapha siphinde sibale nethange likawonyela elisepulazini i-Tarlon elimumatha uwoyela ongamalitha angu 30 million. Lelithange lisetshenziswelwa ukugcina uwoyela kanye nokuwuthumela eBotswana.

Ipayipi legesi lisuka e-Secunda, eMpumalanga linqamule eThekwini liye eMpangeni. Liphinde linqamule eNewcastle naseRichards Bay, eMpangeni naseThekwini. Wonke lamapayipi aphephile

ngoba ayahambisana nemibandela ye-ASME B31.4 okuyimigomo yezokuphepha yeMelika. Lamapayipi ahlale egadiwe amahora angamashumi amabili nane ngosuku emahhovisi e-TPL ePhayindane, KwaZulu-Natal.

Bangu 703 abasebenzi bakwa-TPL, kubalwa nalabo abayitoho. Laba basebenzi babekwe kuzona zonke izindawo lapho amapayipi enqamula khona kanti ikomkhulu lalenkampani liseThekwini, KwaZulu-Natal.

Amakhasimende e-TPL izinkampani ezinkulu zikawoyela uleli kubalwa u-BP, Astron Energy, Engen, Saso, Shell kanye no-Total. I-TPL ivule izandla kwizinampani zikawoyela zosomabhizini abamnyama abasafufusa.

3.5 I-Transnet Engineering:

I-Transnet Engineering (TE), yenza umsebenzi wokucwaninga , ukudizayina, ukwakha kanye nokulunguisa izitimela zabagibeli kanye nalezo ezithwala impahla. Lenkampani inamafemu ayisikhombisa ahambisana nezimiso ze-International Organisation of Standardization (ISO) kanye nabasebenzi abantu 11, 045, kubalwa nalaboa bayitoho . Amakhasimende alenkampani akuleli lase-Africa kanye nasemaZweni angaphandle.

Ingapezulu kuka-150 iminyaka lenkampani ilungisa izitimela nemizila yazo. Kanti ithathwa njengebaluleke kakhulu kwimboni yezeitimela kuleli kanye nasezwenikazi lase-Africa ngoba imishini yayo ezakhela yona iseizingeni lomhlaba kanti idlala indima ebalulekile ekukhuliseni umnotho wezwekazi lase-Africa nasekuthuthukiseni amakhono ezobunjiniyela.

Nansi eminye imisebenzi eyenziwa i-TE:

- Ibhizinisi lezitimela: TE ihamba phambili ezwenikazi lase-Africa kwezokuthengiswa kwezitimilea zikagesi, ezikadizili kanye nezisebenza ngodizili nogesi, kanti futhi ihamba phambili uma kuziwa kwezokuhiqizwa kwezitimela. Ngapezulu kokukhiqiza izitimela iphinde futhi ilungise lezo ezidunga ukulungiswa.
- Ibhizinisi lamakhoji: I-TE yakha iphinde ihlele kabusha amakhoji ezitimela nanoma iluphi uhlobo lwento ehamba emzileni kaloliwe ngendlela engambi eqolo.
- Ibhizinisi lezinqola: I-TE isebezisa ubuchwepeshe besimanje ukwenza lokho okudingwa ngamakhasimende.
- Ibhizinisi lokulungisa izitimela: I-TE iphinde ilungise konke okuyimikhiqizo yayo.
- Isikole sobunjiniyela: I-TE yenza uqequesho olugunyazwe ngokusemthethweni olusezingeni eliphezulu olugxile ezintweni ezahlukene eziphathelene nemboni yezobunjiniyela.

3.6 I-Transnet Property okanye i-TP

I-Transport property yasungulwa mhla lulunye ku-January ka2008 ngokuhlanganisa i-Propnet kanye ne-Transnet Housing. Ngesikhathi isungulwa, ibigxile ekwengameleni impahla yenkampani ethathwa njengengabalulekile kuze kube iyachithwa okanye iyasatshenziswa. Lenkampaniiphinde isebeenze ukwengamela izakhiwo.

Namuhanje i-TP ingenye yezinkampani ezingamele izakhiwo ezaziwayo kuleli. I-TP ingamele izakhiwo ezisetshenziselwa imisebenzi yayo ebalulekile kanye nalezo ezingenisa imali ye-renti kwabaqashile. I-TP iphinde yenze umsebenzi wokukala intengo yezakhiwo iphinde ihlole nomhlaba, ukudwetshwa kwamapulani kanye nokwengamela amaphepha obunikazi bezakhiwo.

Izindlu zokuhlala nezingamahhovisi ezingaphansi kwe-TP zingabiza u-R6.5 billion, sekuhlanganiswe zonke izakhiwo zakwa-Transnet ezingabiza uR35 billion. Enye impahla inganyelwe ngezinye izihlaka zenkampani. Izakhiwo zamahhovis ezingaphansi kwe-TP kubalwa amahovisi, izakhiwo zezimboni, ezokuhweba kanye nomhlaba. Izindwo zokuhlala ezingamelwe i-TP zifaka phakathi izindawo ezingahlali muntu, izindlu ezihlala abantu kubalwa amahhotela, amaloji nezindawo zokukhempa.\

Amanye amakhasimende amahhovisi e-TP kubalwa ihhovisi likaNdunankulu wase-Freyistata, amahhovisi omnyango wezempiro eNyakatho Kapa, amahhovis oKlebe phecele ama-Hawks eGqeberha, umkhandludolobha wasekapa, amahhovisi ePrasa kanye nebhang i-First National bank. Kwizakhiwo zezimboni nezezitolo amakhasimande e-TP afaka phakathi u-Shoprite, Rovos Rail Tours, Grinrod Intermodal Transport, DHL Courier Services kanye ne-Aspen Pharmacare. Amakhasimende abalulekile kwisifunda esiseMpumalanga inkampani kawoyela i-BP, Mlazi Mega City kanye ne-Barlow Motor Investments.

Inxanxathela yezeitolo i-Carlton Centre eGoli ngesinye sezakhiwo ezingaphansi kwe-TP. Sinamakhasimende ahlukene afaka phakathi i-Pic'n Pay, Woolworths, Termberland, Truworts, Spits, Mr Price Kiddies, Nedbank, Standard Bank, Capitec Bank, Clicks, McDonald, Nandos kanye no-Steers. Nakuba okwamanje iCarlton Hotel ingasebenzi kodwa kunezhlelo ezikhona zayo ezhlelelw isikhathi esizayo.

6.UKUFAKA ISICELO SOKUTHOLA IMINININGWANE EKWA-TRANSNET

Nakhu okulandelayo okumele kwenziwe ngaphambi kokuthi kufakwe isicelo;

6.1 Step 1: Ingabe unalo igunya lokusebenzisa i-PAIA ukufaka isicelo sokuthola imininingwane ?

6.1.1 Bheka isigatshana 7(1) se-PAIA esibeka kanje:

"Lomthetho angeke usetshenziswe ukuthola imininingwane eseziinhlakeni zikaHulumeni okanye ezinkampanini ezizimele uma –

- (a) leyo mininingwane ifunelwa ukuthi isetshenziswe emacalen;
- (b) Uma leyo mininingwane ifunwa ngemua kokuqala kwecala.
- (c) UkuNikzelwa kweminingwane ngaphansi kwestishana a kungenziwa ngaphansi komunye umthetho. "

6.1.2 Uma ngabe isigatshana 7(1) sisengasetshenziswa akumele ufake isicelo sokuthola imininingwane ngaphansi komthetho i-PAIA. Kumele usebenzise imithetho nemigudu yokuthola imininingwane yohlaka lomthetho olufaneleyo kanye nasenkundleni okuyona.

6.1.3 Kumele ulandele isigaba 45 se-PAIA esigunyaza i-Transnet ilungelo lokunqaba isicelo sokuthola imininingwane uma; isicelo kuhloswe ngaso ukuchitha isikhathi okanye ukususa uchuku noma uma ukufunwa kweminingwane kuzophoqa i-Transnet isebeenzise izinsizakusebenza zayo ngokungenasidingo.

6.2 Kungabe imininingwane edingakalayo ikhona yini kuma-rekhodi?

6.2.1 Qaphela ukuthi i-PAIA isebeenza kuphela uma ngabe ekhona ama-rekhodi adingakalayo ngesikhathi kufakwa isicelo.
